### **COMPANY SECRETARY (CS)**

Company Secretary is a professional whose role in a corporate set up is that of an advisor for legal matters. As per the Companies Act, a statutory requirement is that companies with a paid up share capital of minimum of Rs. 5 Crore are required to appoint a Company Secretary. CS Course is conducted & regulated by The Institute of Company Secretaries of India (ICSI) which is constituted under an Act of Parliament i.e. the Company Secretaries Act, 1980.

#### **COMPANY SECRETARY COURSE AT A GLANCE**

The Company Secretary course comprises of 3 Stages:

1. CSEET 2. Executive 3. Professional

**STAGE-I: CSEET** - It is a Gateway to the course of Company Secretary. The candidates appearing/passed in class 12th examinations shall be eligible for appearing in the CSEET. All the students seeking admission in the Company Secretary Course including graduates/post graduates, etc. shall be required to qualify the CSEET from Feb. 3, 2020 onwards.

The Institute will conduct CS Executive Entrance Test based on Objective Type/Multiple Choice Questions and viva-voce for testing listening, written communication and oral communication skills. There are four papers in CS-Executive Entrance Test. Each paper contains objective type multiple choice questions having one or more marks each with four options with one correct answer. The duration of the Test shall be 120 minutes and viva-voice on Presentation and Communication Skills of 15 Minutes.

**STAGE-II: CS-EXECUTIVE** -After passing CSEET exam or completing the graduation, a student can register with ICSI for Executive program. CA-CPT passed students is also eligible for CS-Executive Course. It comprises of 2 Groups with 8 subjects (Group-I: 4 subjects & Group-II: 4 subjects). Minimum 40% Marks in individual subjects and 50% aggregate in each group is required to pass the exam.

A candidate will be eligible for appearing into executive program only after completing 70 hrs. of compulsory training conducted by institutions approved by ICSI in respective cities.

**STAGE-III: CS-PROFESSIONAL** - A student can be admitted to professional program on passing the Executive Stage and only completion of 9 month from passing Executive program. Exam will be held twice in a year (June, Dec). They are 3 groups (each having 3 subjects) in CS-Professional. Minimum 40% Marks i individual subjects and 50% aggregate in each group is required to pass the exam. Every registenred student has to undergo a practical training as per ICSI norms.

## **CHARTERED ACCOUNTANT (CA)**

Chartered Accountancy is a rewarding profession where one can practice his/her own or can do job in various public and private sector companies. CA Course is conducted & regulated by The Institute of Chartered Accountants of India (ICAI) which is a statutory body established under the Chartered Accountants Act, 1949.

#### CHARTERED ACCOUNTANCY COURSE AT A GLANCE CA course comprises of 3 Stages:

**STAGE-I: CA-Foundation -** CA-Foundation is a Gateway to the course of charted Accountancy.- Students after passing Class 10th examination conducted by an examining body constituted by law in India or an examination recognised by the Central Government or the State Government as equivalent thereto, may provisionally register in Foundation Course of ICAI.

(a) Student has to register with the Board of Studies of the Institute on or before 1st day of January or 1st day of July for the examination to be held in the months of May/June or Nov./Dec. respectively. In other words, 4 months study period is required before appearing in Foundation Examination.

(b) Student should have appeared in the Senior Secondary (10+2) Examination conducted by an examining body constituted by law in India or an examination recognised by the Central Government (or the State Government) as equivalent thereto (for the purpose of admission to graduation course) Qualify Class XII examination (if not done earlier) Appear for Foundation examination in November/May after passing 10+2. Examination. It is a Subjective & Objective type Paper of 400 Marks. Minimum 40% Marks in individual subjects & 50% aggregate is required to pass the exam.

**STAGE-II: CA-Intermediate Professional Course (IPC)** - After passing CA-Foundation exam, one needs to register for CA-Intermediate (IPC) and can appear in exams after the 9 months of registration. It

**STAGE-III: CA-FINAL** - After passing either Group-I, Group-II & Both Group of Intermediate examination, student have to register for practical training of 3 years under any practicing chartered accountant. Students can appear for the final exam after completing the training of 2.5 years. CA-Final is also conducted twice in a year (May & November). It comprises of 2 group (each having 4 subjects). These are subjective papers conducted on separate days for each subject. As they clear the final examination, complete the practical training and also General Management and Communication training they are qualified to become a member of ICAI. comprises of 2 Groups with 8 subjects (Group-II: 4 subjects). Minimum 40% Marks in individual subjects and 50% aggregate is required to pass the exam. A graduate and post graduate student from commerce stream with 55% marks and non-commerce students with 60% marks can directly register in IPC Course.

## **COMMON LAW ADMISSION TEST (CLAT)**

Started in 2008, the CLAT exam is an All India Entrance Examination conducted by 22 National Law Universities (NLUs) for admissions to their Undergraduate (LL.B) and Postgraduate (LL.M.) degree programs. CLAT-2021 will be conducted in 13th June, for 2984 + Seats in LL.B & 500 + Seats in LL.M of 22 NLUs. CLAT 2021 Examination is being conducted in Offline Mode & Objective Type. CLAT-UG is an Objective Test Covering English Language, Current Affairs, including General Knowledge, Legal Reasoning, Logical Reasoning & Quantitative Techniques. The UG-CLAT 2021 shall be a 2-hour test, with 150 multiple-choice questions carrying 1 mark each. There shall be negative marking of 0.25 marks for every wrong answer.

Eligibility for Under-Graduate Programs : A candidate should have obtained a Senior Secondary School/Intermediate (10+2) or its equivalent qualification from a recognized Board with not less than 45% Marks in aggregate (40% in case of SC/ST/OBC and PWD). Candidates who have appeared in the 10+2 examination and are awaiting results are also eligible to appear in test.


