## COMMON LAW ADMISSION TEST (CLAT)

Started in 2008, the CLAT exam is an All India Entrance Examination conducted by 22 National Law Universities (NLUs) for admissions to their Undergraduate (LL.B) and Postgraduate (LL.M.) degree programs. CLAT-2024 will be conducted in Dec. Month for 2801 + Seats in LL.B & 1072 + Seats in LL.M of 22 NLUs. CLAT 2024 Examination is being conducted in Offline Mode & Objective Type. CLAT-UG is an Objective Test Covering English Language, Current Affairs, including GK, Legal Reasoning, Logical Reasoning & Quantitative Techniques. The UG-CLAT 2024 shall be a 2 Hrs. Test, with 120 multiple-choice questions carrying 1 mark each. There shall be negative marking of 0.25 marks for every wrong answer.

**Eligibility for Under-Graduate Programs :** A candidate should have obtained a Senior Secondary School/Intermediate (10+2) (Science / Commerce/ Humanities) or its equivalent certificate from a recognized Board with not less than 45% marks in aggregate (40% in case of SC and ST candidates). There is no upper age restriction for the test.

In case of equal marks, the break of tie shall be by the following procedure and order as under: Post-Graduate Courses

(i) Higher marks in the component/section on legal aptitude in the CLAT 2025 exam; (ii) Higher age; (iii) Computerised draw of lots. Eligibility for Post-Graduate Programs :

LL.B/B.L. Degree or an equivalent degree from a recognized University with not less than 50% marks in aggregate (45% in case of SC and ST candidates).

No upper age limit is prescribed for appearing in CLAT 2024. Tie Breaker Rule : In case of equal marks, the break of tie shall be by the following procedure and order as under:

## HOW TO DEPOSIT THE FEE

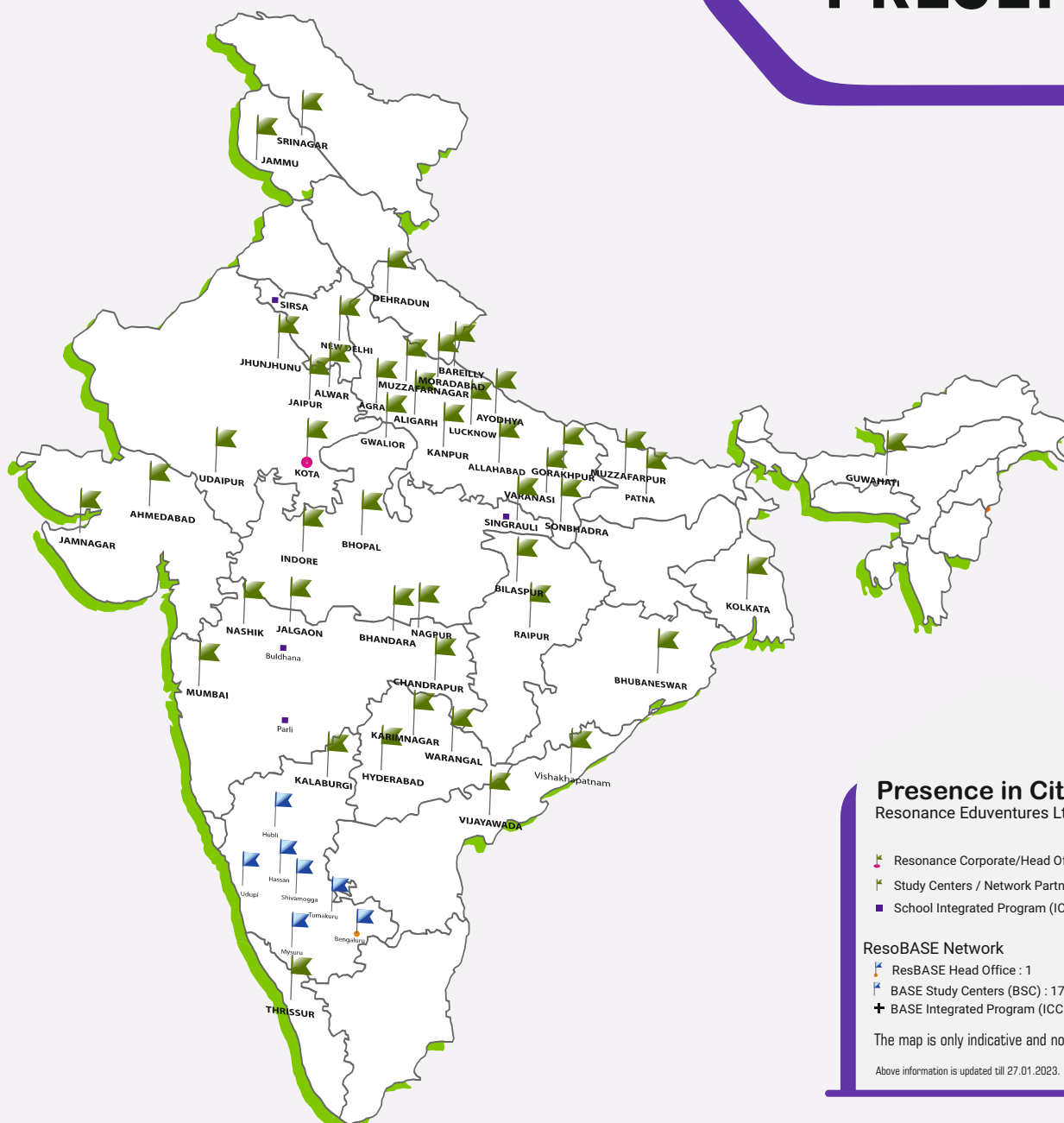

- Students must ensure that at the time of submission of the Challan's copy to the institute, Branch Code and Journal Number must be mentioned on it. This Journal number would be issued by the Bank.
- The student should preserve the original copy of fee deposition (it may be Challan Copy/Bank Receipt or the Receipt issued by institute) throughout the academic session. The student may be asked to produce it as and when required in the institute.
- The actual date of course commencement is reserved by the institute. The course end date will consequently undergo change in accordance with the course duration.
